### **STAND BUILDUP**

Access to the exhibition spaces for stand build-up is allowed from **Friday May 16<sup>th</sup> until Tuesday May 20<sup>th</sup>**. **PLEASE REFER TO THE SUMMARY TABLE FOR THE ENTRANCE DATES.**

Anticipated entry and extra-time must be agreed with the show Organizing Office ([info@hydrogen-expo.it](mailto:info@hydrogen-expo.it) / [info@cybsec-expo.it](mailto:info@cybsec-expo.it) / [info@nuclearpower-expo.it](mailto:info@nuclearpower-expo.it)).

**Shell scheme stands will be available to the exhibitors starting from Tuesday 20<sup>th</sup> May - 8,00 am.**

It is not allowed to start dismantling of the stands before the end of the fair (5,00 pm).

On **Friday May 23<sup>rd</sup> from 5 pm to 7 pm**, exhibitors are allowed to remove only materials that can be carried by hand from the stand. Access of service vehicles up to 3.5 tons will be allowed, only outside the pavilions.

Stand dismantling operations can be carried out from **Saturday May 24<sup>th</sup> until Monday May 26<sup>th</sup> from 8:00 am to 6:00 pm**. To bring any equipment, material or product out of the fairgrounds, the exhibitor or the stand builder must present the Exit Voucher issued by the S.A.T.E. office (exhibitor technical assistance office) once all payments have been made.

### **STAND DESIGN**

Setting-up must be done within the assigned exhibiting space.

Stand designs passing **over 2,50 mt.** of height must be submitted through a written request to the approval of the technical office and the same is valid for **two-floors stands** that will not allowed to pass **5 mt.** height.

### **ACCESS TO THE SHOWGROUNDS**

In order to access the showground to start with stand build-up operations, every exhibitor and/or build-up personnel has to show to the surveillance people the **SETTING-UP PASS** that will be downloadable from the [www.hydrogen-expo.it](http://www.hydrogen-expo.it) / [www.cybsec-expo.it](http://www.cybsec-expo.it) / [www.nuclearpower-expo.it](http://www.nuclearpower-expo.it) website.

### **STAND SURVEILLANCE**

**Only the exhibitors are responsible for care and surveillance of the stand, either during the show time and the buildup/dismantling time. (see points 15-17-19 of the General Regulations)**

### **MACHINES WITH HEAT ENGINE – TRACKED VEHICLES**

Machines and equipment equipped with a heat engine can only be displayed in the pavilions with the amount of fuel strictly necessary to enter and exit the pavilion. The battery must be disconnected and the fuel tank must be locked. **Internal combustion engines mustn't operate inside the pavilions.** Each demonstration can only be carried out in the external area of the fairgrounds. To access the pavilion with vehicles equipped with steel tracks, a special permit must be requested from the Piacenza Expo Technical Office. The exhibitor is responsible for any damage caused to the flooring.
